§ 227-9.1. Penalties and violations  
[Added 12-10-2018 by Ord. No. 1898-2018]

Non-life hazard inspection fees shall be paid within thirty (30) days of the completed inspection. All fire code violations that were issued penalties shall be paid for as stated in the notice of violation. Failure to pay non-life hazard inspection fees within thirty (30) days or to pay violation penalties as issued shall be fined two-hundred dollars (\$200.). Continued failure to comply may result in fines up to two-thousand dollars (\$2,000.) and a summons to appear at the Perth Amboy Municipal Court.
