5. New Business:

- A) Placing a new notice to the following newspapers Home News Tribune, Star Ledger, Amboy Beacon, for the reminder of meetings in 2009. That notice shall state that this is the schedule of regular meetings and closed session meetings of the Planning Board for the remainder of the calendar year of 2009.

- F) Request the Zoning Officer to set up advanced training classes for all the members of the Planning Board.
- G) Discuss the creation of the Minor Subdivision committee, pursuant to Perth Am boy code 430-25J, and appointment of said committee by Board Chair at a subsequence meeting.
- H) Discuss the viability of Perth Amboy code provision 430-25 N, which established a Technical Advisory Committee. That committee was charged with reviewing new applications for development or informal reviews referred to it by the Planning Board or Zoning Board. This discussion must include the administration and the Department of Code Enforcement. If it is determined that this committee does not effectively function as created by the Ordinance, then we must address reshaping the Ordinance and providing a proposed Ordinance to the City Council.
