Interested respondents **must submit one (1) original and one (1) digital version (USB) of your proposal** and must be submitted to the City in a sealed envelope, clearly marked on the outside with the word "**Confidential,**" and indicate the service(s) **for which the RFB "CONTRACTING SERVICES FOR THE CITY OF PERTH AMBOY'S ROLL GATE REMOVAL PROGRAM".** RFB's must be addressed to: Division of Purchasing, City of Perth Amboy, 260 High Street, Perth Amboy, New Jersey 08861, to be received no later than **9:00 A.M. prevailing time on Tuesday, August 18, 2026.**

Respondents with questions or requiring clarification or interpretation of any section within this RFB must address these questions in writing via email to ProcurementQPA@perthamboynj.org. **The deadline for posting questions and requests about the RFB is Tuesday, August 11, 2026, at 10:00 A.M. (prevailing time).**

Respondents are required to comply with N.J.S.A. 10:5-31, et seq., P.L. 1975, c. 127, N.J.A.C. 17:27-1 et seq., and all other applicable laws, regulations, or ordinances concerning affirmative action goals and equal employment opportunity.

The City reserves the right to consider submitted RFB's for sixty (60) days after receipt, and further reserves the right to reject any and all submissions, waive informalities, and make an award or take any other action as may be in the best interest of the City, consistent with applicable law.
